I understand that yacht racing can be dangerous and that neither the China Coast Regatta 2011 Race Committee, the Royal Hong Kong Yacht Club, sponsor(s) and persons working for or on behalf of the above accept any responsibility for any loss of life or injury to members of my crew or other parties, or for the loss of, or damage to my vessel. I have read and understand RRS Fundamental rule 4 – Decision to Race.

The yacht will be available for inspection by the Race Committee at any time. I shall notify the Race Committee immediately if any alteration likely to affect the rating (such as to sail plan, mast, ballast, trim, engine, propeller or hull measurement) is made.

I will ensure that no crewmember races on my yacht contrary to the terms of any ban imposed by any National Authority.

I understand and agree that the information I give to the Organising Authority will be maintained as computer records for the purposes of race administration.

Before the start of the race I will ensure that all crew members are aware of all undertakings included in this Declaration and of the importance of effecting appropriate personal insurance.
